Football Foundation - £9,834.00 received previous year in respect of the third year Grant for Pitch Maintenance. We had spent £7,247.18. This left a balance of £2,586.82 carried forward at the end of last year. In this current year we have spent a further £1,490.10 – as yet to be agreed with the Football Foundation. This would leave a balance of £1,096.72 included in our Current Account.

Secretary: The club continues to provide football for significant numbers of children. The girls' groups in particular have seen ever-increasing numbers and we plan to start a girls' under 10 group for the coming season. It's great to see the enjoyment and progression of do many youngsters at training and at matches. The clubs under 12s won both the League and Cup in their age group.

In terms of managing and progressing the club, as well as running 15 teams the committee is working on four main fronts – 1. repairing the Astro FA testing has deemed it fit for training but not for matches (awaiting quotes), 2. replacing the Astro (4 companies asked to quote, 3 responses to date), 3. Incorporation and 4. Club Development involving an initial self-assessment process based on an FA programme. On all these fronts we are working with outside bodies to ensure we get the best value whilst mitigating risk and meet all legal and financial requirements.

Alongside this the club is looking to move from a Trust to becoming Incorporated – more on that in the proposals to come later in the meeting.

All of the above puts a strain on the club's finances. If anyone can help, say with grants, please let a committee member know.

Membership:report for 2023/24 season.

We finished the year with 272 paid up members, a small increase from last season. 216 boys and 56 girls. We lost several members when teams folded/reorganised but girls especially seem to be increasing well in numbers.

Constitution/club structure Proposals: -

The club is currently an unincorporated body, a members' club under trusteeship. Following legal advice, the proposal is that the club becomes incorporated as a company limited by guarantee and with registered CASC (Community Amateur Sports Club) status.



Reasons for the proposal:

- To protect the facility
- To protect the Trustees from risk of personal liability
- Succession Planning has long been an issue at the club: this would improve better paths for succession and improve long term sustainability. Incorporation would mean the club having directors rather than Trustees.
- To allow more grant and borrowing opportunities particularly in relation to astro and clubhouse refurbishments. Our current structure does not allow access to some funding routes.

Pete Evans felt that this would give us more clarity and some of our grant applications have not been accepted due to our legal aspect. We would need clarity around the membership status. Pete approached Edward Jones a while ago and they might be interested in the legal side of things but not the accounts. Pat asked how would this affect the committee. Currently we have 3 trustees who sit above the general committee. The new constitution would ensure more protection to the club and our assets and the committee members would be directors if voted on. Simon asked if we are a limited company if we made a profit at the end of the year would we have to pay tax. AL answered no, and we probably would not make enough profit but we are on the borderline. VAT issue was discussed and the conclusion around the table under VAT registration which would be held for 10 years the club did not want to accept.

The committee then voted and the majority agreed to move forward on this. This process could take several months to put this in place and hopefully by our next AGM the process will be in place. Andy would you mind checking the above section for accuracy and amend accordingly

Other proposals for discussion: match fees, increase or not? (ref fees have increased), record keeping of match fees, how match fees may be used.

All members voted that each coach should have a minimum of one parent helper that will come to committee members so they can feedback to coach and other parents.

All match fees should be recorded next season and submitted to the Treasurer by each coach. This will be presented at next years AGM so we have auditable records.

Next year ref fees have increased, from next season refs fees will be:-

U11s & U12s = £25

U13s & U14s = £30

U15s and U16s = £35

Pete to send me some notes

Match fees will be explored by Simon for the U8s - £10s.



Match fees will be £2.00 home and away from U11's – U16s.
